You will waive all rights to pursue any claim for damage or loss, including any veterinary bill you incur.
- 3.) Financial responsibility for injuries, diseases, or death in daycare or in the boarding facility is assumed by the owner of said pet. If such an event should occur, be aware that your name, telephone number(s), and address may be released to the injured party's owner.
- 4.) Failure to claim your animal(s) after 10 days from the agreed period of daycare and/or boarding will be deemed an abandonment of your animal(s) by Summit Pet Care, Inc., and Summit Pet Care then reserves the right to dispose of your animal(s) at the end of that period.
- 5.) In the event that an action is filed by Summit Pet Care, Inc. due to your failure to pay any sum of money owed by you under this agreement, Summit Pet Care, Inc. shall in addition to all sums due and owing, be entitled to recover from you a reasonable sum for its attorney's fees.
